Caritas Macedonia's humanitarian assistance has provided vital relief items such as food, clothing and medical assistance to the most vulnerable groups of people. Caritas Macedonia programme helps poor families who either have no income or their social assistance is 30-50 euros a month; provisions that include the basic necessities of food, clothing and medicine. A major aspect of the work of Caritas Macedonia is a 9 month education project for 170 Roma children, women and girls, so that they can learn to speak and write the Macedonia language, which is a requirement for entering primary education.

The National Office of Caritas Macedonia is located in Skopje and has Caritas parishes in all parts of the country. The local bishop serves as President while the organisational work is entrusted to the Director. The Caritas parishes are led by the parish priest and volunteers help carry out their humanitarian mission

Caritas Mali's areas of intervention include: charitable and emergency humanitarian assistance initiatives; food security via promotion of grain storage warehouses; environmental protection, accompaniment of farmers' organisations, rural extension, natural resource management; and awareness-raising and facilitation relating to health and sanitation.

Regarding local economic development, Caritas Mali provides credit unions and supports income-generating activities and local initiatives. On the healthcare front, Caritas supports community health services, strengthens infrastructure and combats HIV/AIDS.

Caritas Mali also works for the promotion of women by encouraging handicraft and vocational training courses, as well as projects that support women's groups. Caritas pastoral care: accompanies the diocesan Caritas, supports people with HIV/AIDS, promotes gender equality and helps in emergencies caused by natural disasters and social crisis situations.

Pastoral care of workers: in the interest that all human activities may be dignified and contribute towards social progress.

Pastoral care of indigenous peoples: training of indigenous peoples – most of whom come from states in southern and south-eastern Mexico – so that they can play key roles in their own integral development.

Pastoral care of prisoners: aimed at boosting the training of those deprived of their freedom and their families. In Mexico, 80 per cent of the prison population is under 30 years, with low incomes and little education.

Human mobility: responds to the situation of transit, destination, deportation and trafficking of emigrants and immigrants from an overall perspective, by seeking to deal with the causes in order to reduce migration flows and exploitation of human beings.

Collaboration with other Caritas organisations has been vital to the work of Caritas Mongolia. It has allowed it to expand its programmes to include education, social and humanitarian assistance, migration and the rebuilding of livelihoods. One of the main intervention areas of Caritas Nepal is to promote sustainable agriculture to enable small farmer households to realise food security and sustainable livelihoods, as about two thirds of the population is dependent on agriculture for livelihood. Collaborating with Caritas Australia, they implemented a national campaign, "IPM Program for Small Farmers", in 24 districts of Nepal to distribute seeds, promote the use of vermin-composting and animal waste for organic fertilizers, and advocate for small farmers to improve their household food security, incomes, and farming sustainability.

In addition, Caritas Nepal instituted a national programme on prevention of trafficking and HIV/AIDS, through measures such as awareness-raising sessions, a radio programme and street drama. Smaller projects, often carried out through partner agencies, include skills development, savings and credit programmes, and education programmes for children displaced by the war.

The NHRC was established in 2002, in order to uphold and promote the human rights in the International Treaties to which the State of Qatar has acceded. NHRC does have a Legal Department, which is in charge with receiving and recording complaints, and with helping individuals to solve or mitigate their problems. The Committee undertakes a number of additional activities, such as visiting the Detention Centres and Prisons in Qatar; training programs for police and other officials to help ensure that abuses are avoided and providing legal advice regarding the sponsorship law or the labour law.
